

Cleo Communications US, LLC Software End-User License Agreement

This Cleo Communications US, LLC Software End-User License Agreement ("EULA") is a legal agreement between you, either an individual or a single entity, and Cleo Communications US, LLC ("Cleo") for the following:

Cleo LexiCom[®] Cleo VLProxyTM

which includes the User's Guide, any associated software components, any media, any printed materials other than the User's Guide, and any "online" or electronic documentation (collectively, the "Software"). By installing, copying, downloading, accessing, or otherwise using the Software, you agree to be bound by the terms of this EULA. If you do not agree to the terms of this EULA, do not install or use the Software. If the Software was mailed to you, return the media envelope, UNOPENED, along with the rest of the package to the location where you obtained it within 30 days from purchase.

Cleo may modify this EULA from time-to-time, as it deems necessary or appropriate. Any differences between this EULA and the online version are superseded by the online version.

This EULA shall supersede all other agreements either verbally or written.

1. <u>GRANT OF LICENSE</u>.

a. <u>License</u>. The Software is licensed to you, not sold. In consideration of payment of licensing fees for the Software, Cleo hereby grants to Customer, along with its subsidiaries and affiliates, a perpetual, non-transferable, non-exclusive, royalty-free license to use such Software. Cleo shall provide Customer with one (1) copy of the Software in object code form, via download or CD/ROM, along with the accompanying documentation. The term of such Software license shall commence on the date of delivery of such Software to Customer. The Software and documentation may be used by Customer's contractors solely for Customer's business operations in accordance with the terms of this Agreement, and Customer shall be responsible for the compliance of contractors with the terms of the Agreement.

b. <u>Registered Copy</u>. After you have purchased the non-exclusive, non-transferable license to use the Software and have received a permanent license key, and subject to the terms of this EULA, you are licensed to copy the Software only into the memory of the number of computers corresponding to the number of licenses purchased. Under no circumstances may the Software be operated at the same time on more than the number of computers for which you have paid a separate license fee. You may not duplicate the Software in whole or in part, except that you may make one copy of the Software for backup archival purposes. You may terminate this license at any time by destroying the original and all copies of the Software in whatever form. You may permanently transfer all of your rights under this EULA provided you transfer all copies of the Software (including copies of all prior versions if the Software is

an upgrade) and retain none, and the recipient agrees to the terms of this EULA. Cleo must be notified of any transfer in ownership at the address shown in Section 11.

c. <u>Evaluation Copy</u>. If the Software is provided to you for evaluation purposes you may use the Software without charge on an evaluation basis until the temporary license that accompanied the software expires. You must pay the license fee and register your copy to continue to use the Software after the temporary license expiration date.

d. <u>Title</u>. All title and intellectual property rights in and to the Software are owned by Cleo. All rights not expressly granted under this EULA are reserved by Cleo.

2. <u>RESTRICTIONS</u>.

a. You may not reverse engineer, de-compile, disassemble, or otherwise attempt to create the source code from the Software.

b. The Software is licensed to you for use only on a single computer system. THIS SOFTWARE IS LICENSED TO OPERATE ONE CONCURRENT SESSION ON A SINGLE COMPUTER.

c. You may not use the Software to communicate to more Trading Partners than you are licensed for.

d. You may not use the Software to perform any unauthorized transfer of information (e.g. transfer of files in violation of a copyright) or for any illegal purpose.

e. You may not rent, sell, lease, lend, or otherwise transfer or distribute the Software to others.

f. You may not remove, hide, move or alter any trademark, logo, copyright, or other proprietary notices, legends, symbols, or labels in the Software.

g. You may not modify, or create derivative works based upon the Software, in whole or in part.

h. You may not use the Software to operate a service bureau facility to the benefit of third parties unless you first acquire a Cleo VLTrader[®] Service License from Cleo.

3. <u>SUPPORT SERVICES</u>. Cleo may provide you with support services related to the Software. Use of support services is governed by Cleo polices and programs described in the User's Guide, online documentation, and/or other Cleo-provided materials, as they each may be modified from time-to-time. Any supplemental Software code provided to you as part of the support services shall be considered part of the Software and subject to the terms and conditions of this EULA. With respect to technical information you provide to Cleo as part of the support services, Cleo may use such information for its business purposes, including for product support and development. Cleo reserves the right to obtain customer metrics regarding such criteria as up-time, usage, performance, and others in its effort to improve product and market features. Cleo will not utilize such technical information in a form that personally identifies you.

4. <u>**TERMINATION**</u>. This EULA shall terminate automatically if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of the Software. You may terminate this license at any time by destroying the original and all copies of the Software in whatever form they may be.

5. <u>COPYRIGHT</u>. The Software is protected by United States copyright law, as well as, other intellectual property laws and international treaty provisions. You acknowledge that no title to the intellectual property in the Software is transferred to you. You further acknowledge that title and full ownership rights to the Software will remain the exclusive property of Cleo and you will not acquire any rights to the Software except as expressly set forth in this license. You agree that any copies of the Software will contain the same proprietary notices which appear on and in the Software.

6. <u>EXPORT RESTRICTIONS</u>. You agree to not export or re-export the Software to any country, person, entity, or end user subject to U.S.A. export restrictions. Restricted countries currently include, but are not necessarily limited to, Cuba, Iran, Libya, North Korea, Sudan, and Syria. You warrant and represent that neither the U.S.A. Bureau of Export Administration nor any other federal agency has suspended, revoked or denied your export privileges. You acknowledge and agree that you are solely responsible for compliance with any and all export rules and regulations.

7. <u>WARRANTY</u>. Cleo warrants for a period of one year from the date of shipment or download notification by Cleo to you, Cleo's reseller, and/or the reseller's customers, as applicable, that the Software, in its unmodified form as initially delivered, will perform in all material respects in accordance with Cleo's published specifications. Cleo's sole obligation and liability shall be to replace or repair, at Cleo's option, the Software found to be defective and subject to this warranty so that it will perform in material conformance with the applicable specifications.

EXCEPT AS OTHERWISE PROVIDED, CLEO DISCLAIMS ALL IMPLIED WARRANTIES INCLUDING WARRANTIES OF MERCHANTABILITY AND FITNESS FOR USE OR FOR A PARTICULAR PURPOSE. CLEO DOES NOT WARRANT THAT THE SOFTWARE WILL BE ERROR-FREE OR WILL OPERATE WITHOUT INTERRUPTION.

SOME STATES PROHIBIT EXCLUSION OR LIMITATION OF DAMAGES FOR CONSUMER PRODUCTS. IF YOU LIVE IN ONE OF THESE STATES, THESE LIMITATIONS MAY NOT APPLY TO YOU. THIS WARRANTY PROVIDES YOU WITH SPECIFIC LEGAL RIGHTS, AND YOU MAY HAVE OTHERS DEPENDING ON THE STATE IN WHICH YOU LIVE.

8. <u>LIMITATION OF LIABILITY</u>. IN NO EVENT SHALL CLEO, ITS SUPPLIERS, OR ITS PARTNERS BE LIABLE TO YOU FOR ANY CONSEQUENTIAL, EXEMPLARY, INCIDENTAL OR PUNITIVE DAMAGES, INCLUDING ANY LOSS OF BUSINESS, REVENUE, SAVINGS, PROFITS, USE, DATA, GOODWILL, OR ANY OTHER DAMAGES, WHETHER IN AN ACTION OF CONTRACT, NEGLIGENCE, PRODUCT LIABILITY, TORT OR OTHERWISE, ARISING OUT OF OR IN CONNECTION WITH THE DELIVERY, USE, INABILITY TO USE, OR PERFORMANCE OF ANY CLEO PRODUCT EVEN IF CLEO HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGE OR OTHER CLAIMS. THESE LIMITATIONS SHALL APPLY NOTWITHSTANDING ANY FAILURE OF ESSENTIAL PURPOSE OF ANY LIMITED REMEDY. IN ANY EVENT, CLEO'S LIABILITY FOR ANY CLAIM, WHETHER IN CONTRACT, PRODUCT LIABILITY, NEGLIGENCE, TORT, OR ANY OTHER THEORY OF LIABILITY WILL NOT EXCEED THE GREATER OF \$1.00 OR THE FEES PAID BY YOU FOR THE APPLICABLE SOFTWARE.

Cleo shall hold harmless and indemnify you from all costs and expenses incurred, including reasonable legal fees, and defend against suits based on any claim that the use of the Cleo product under this Agreement infringes on any patent, copyright, trademark, trade secret, or other proprietary right of a third party, provided you give Cleo prompt written notice of such suits, permits Cleo to control the defense thereof and cooperates with Cleo in its defense efforts.

If such a claim has occurred, or in Cleo's opinion is likely to occur, you agree to permit Cleo, at its option and expense, either to: (a) procure for your right to continue using the Product; (b) replace or modify the Product so that it becomes non-infringing; or (c) if neither of the foregoing alternatives is reasonably available, refund to you the price originally paid by you to Cleo for such Product as depreciated or amortized by an equal annual amount over five (5) years from date of original shipment.

9. <u>U.S. GOVERNMENT RESTRICTED RIGHTS</u>. The Software is provided with RESTRICTED RIGHTS. Use, duplication, or disclosure by the Government is subject to restrictions as set forth in subparagraph (c)(1)(ii) of The Rights in Technical Data and Computer Software clause of DFARS 252.227-7013 or subparagraphs (c)(i) and (2) of the Commercial Computer Software- Restricted Rights at 48 CFR 52.227-19, as applicable. 11. <u>MISCELLANEOUS</u>. If you acquired the Software in the United States, this EULA is governed by the laws of the state of Illinois. If any portion of this EULA is found to be void or unenforceable, the remaining provisions shall remain in full force and effect. If you acquired the Software outside of the United States, then local laws may apply.
